RULES FOR THE 2026 SEASON

1. ABU DHABI - JANUARY
2. DOHA - FEBRUARY
3. MUSCAT - MARCH
4. MONACO - JULY
5. LONDON - AUGUST
6. AACHEN - SEPTEMBER

CONDITION OF ENTRIES:

Horses and handlers are eligible to participate in all GCAT Shows. Participants may register an unlimited number of owned horses for each GCAT Show; however, the number of leased horses is limited to one per participant per season.

Entries are open to horses registered in any WAHO-recognized studbook by the closing date of entries. The registration fees are QAR 4,000 for each horse per event, while late entry fees are QAR 10,000. Registration fees are non-refundable and non-transferable after the published closing date. Owners withdrawing their horses 10 days prior to the show day without a valid medical reason and authorised medical certificate will receive a penalty of QAR 20,000. Medical certificates must be submitted within 48 hours through the official GCAT registration portal only. If the portal is inaccessible, documents may be submitted by email to support@gcarabiantour.com with time-stamped proof. GCAT, in accordance with the show organizer, reserves the discretion to accept or decline applications and may reject entry forms as needed.

QUALIFICATION REQUIREMENTS:

Only open halter classes will be considered. Yearlings must be weaned, and they may not be shown under the age of six (6) months. Horses, except yearlings, should have qualified for the GCAT event as follows:

1) ECAHO-affiliated Shows:

- a) 1st - 5th place at the World Championship, a Title, a GCAT, an A, or a B Show
- b) 1st - 3rd place at a National Championship, a C International or a European Show
- c) 1st place at a Specific Origin or C National Show

2) **Non-ECAHO countries:**

- a) 1st - 5th place at a GCAT Americas Show
- b) Champion or Reserve Champion or top 10 at the US Nationals
- c) Champion or Reserve Champion or a 1st place in class at the Scottsdale Show
- d) Champion or Reserve Champion in Regional Shows
- e) Champion or Reserve Champion, or 1st - 3rd place in an official National Championship
- f) 1st - 3rd place at the Arabian Breeders World Cup show

3) **AHO Shows:**

- a) Champion or Reserve Champion or a 1st place in class at AHO international shows

QUALIFYING CLASSES:

The total number of entered horses is determined based on the final accepted and paid entries as of the closing date. This number is fixed for the purpose of determining class structure and will not change even if withdrawals occur.

RULES FOR TIES IN QUALIFYING PLACES:

In the event of a tie in the qualifying places of a class, the higher place will be given to the horse with the most points for type. If there is still a tie, the higher place will be given to the horse with the most points for movement. If the highest and lowest points are eliminated, only the remaining points for type and movement are considered in the tiebreak. Failing a decision on either of these, one judge chosen by ballot whose class scores will be used to break the tie.

RULES FOR CHAMPIONSHIPS:

In a GCAT show where the total number of entered horses is **less than 180**, the **top five horses qualify** for the following championships: Yearling Males, Yearling Females, Junior Males, Junior Females, Senior Males, and Senior Females. If the number of entered horses is **more than 180**, **only the top 3 qualify** for the championships. The Gold, Silver and Bronze medal winners will be selected from amongst all the horses which have qualified in their respective classes for each championship.

The Championships will be judged by the following: all the horses qualified for the championship will enter the ring and line up according to the numerical order of their catalogue numbers. The horses will be judged individually, standing and trotting. Each judge will nominate his/her choice for gold, silver, and bronze medals together at the same time, from amongst all the horses qualified for the championship. Points will be given to the nominated horses by the following: a horse nominated by a judge for gold medal will receive 4 points. A horse nominated by a judge for silver medal will receive 2 points. A horse nominated by a judge for bronze medal will receive 1 point. The gold medal will be awarded to the horse with the most votes for gold medal champion. In case of an equal number of votes for the gold medal champion, the gold medal will be awarded to the horse with the highest number of championships points. From the remaining horses: the silver medal will be awarded to the horse with the highest number of championship points. The bronze medal will be awarded to the horse with the 2nd highest number of championship points. In the case of a tie, the 'Rules for Ties' in championships will be followed.

The Judges will not discuss the horses. A fourth horse will be selected, which will become the bronze medal winner should one of the three medal winners be disqualified. This horse will not be announced. If two or more of the medal winners are disqualified, no further substitution will be made. All horses that qualify for their respective championships must take part in the championship. Unless a certificate from the DC veterinarian is produced, failure to compete will disqualify the horse from the show, with its record of score and class placing being deleted and the horse being disqualified from showing for the period of one year from the date of the show. In the event of a disqualification, horses placed behind the disqualified horse will move up a place in the class. Should a horse be sent out of the ring by the judges or taken out by the handler for any reason, it will be deemed to have taken part in the championship. All horses that are awarded a medal in their respective championships must take part in the championship prize-giving ceremony. Unless the DC decides otherwise in which case any representative of the horse may accept the medal without the horse being present. The absence of the horse or any representative to appear in the prize-giving ceremony will disqualify the horse from the show with its record of score in the class and championship placing being deleted and the horse being disqualified from the showing for the period of one year from the date of the show. In the event of a disqualification, all horses placed behind the disqualified horse will move up one place in the championship.

RULES FOR TIES IN CHAMPIONSHIPS:

In the event of a tie in the championships, the higher place will be given to the horse with the highest total points in the qualifying classes. If the highest and lowest points are eliminated, only the remaining points for total, type and movement are considered in the tiebreak. If there is still a tie, the rules for ties in qualifying places will be applied.

RULES FOR 42. All Nations Cup - The Lady Harmsworth Blunt Memorial Trophy:

Horses start for the nation where the owner has his citizenship by the closing date of entry (8th September 2026 via registration form <https://tally.so/r/1A0XDb>). In case of joint ownership with different nations, the decision for one nation only should be given on the entry form.

The Nations Cup will be awarded to the nation whose entries score the highest number of points according to the following scale:

First place in a class	5 points	Gold Medal-Champion (Yearling, Junior, Senior)	6 points
Second place in a class	4 points	Silver Medal Winner (Yearling, Junior, Senior)	5 points
Third place in a class	3 points	Bronze Medal Winner (Yearling, Junior, Senior)	4 points
Fourth place in a class	2 points		
For the remaining places	1 point		

Only the best result of every class for each participating nation will be noted.

To determine the winning nation and the following positions, the best five results for the classes plus the results from the championships of each country qualify.

RULES FOR 42. All Nations Cup - Breeders' Trophy - The Major Ian Hedley Memorial Trophy

This is a perpetual trophy donated by The Hon. Mrs. Mary Ann Wragg and Mrs. Annette Hedley, created in cooperation with the very well-known artist Mrs. Karen Kasper, USA.

The Hon. Mrs. Wragg and Mrs. Hedley had the idea to honour not only the owners, but especially the breeders of the most successful horses. They would like to see recognition given to the country which has bred the most prize winners each year on the occasion of the All Nations Cup show.

Points will be awarded to the horses as in the Nations Cup competition (see above scale), but will be given to the country where the breeder has his citizenship at time of birth of the resp. horse. In case of joint breedership with different nations, the decision for one nation only should be given on the entry form.

RULES FOR CONDUCT OF SHOWS:

All GCAT Shows are following the ECAHO Rules of affiliation of Shows and the rules of the Blue Book.



JUDGES & JUDGING SYSTEM:

Each GCAT Show features a **panel of 14 judges: 9 on the ground for the qualifying classes and 11 for the championships**, with the majority selected from the EAHSC A and B lists. The panel will include no more than three ECAHO National Judges or ECAHO Judges Emeritus/Emerita, with only two assigned per qualifying class and only one assigned per championship. Judges from non-ECAHO Member countries must be selected from the panel of a recognized National Arab Horse Organization. Probationary judges are not permitted. The electronic scoring system evaluates horses based on five criteria: type, head & neck, body, legs, and movement. Judges assign scores from 1 to 20 points, including half-points. The final score for each horse is calculated by removing the highest and lowest scores for each criterion, then summing the remaining scores. Horses are ranked according to their final scores.

DISCIPLINARY COMMITTEE:

In a GCAT Show where the total number of entered horses is less than 180, a minimum of 4 members of the Disciplinary Committee is required, including a veterinarian. If the number of entered horses is more than 180, a minimum of 5 members of the Disciplinary Committee is required, including 2 veterinarians. Probationary Disciplinary Committee members are not permitted.

Two Ringmasters are officiating at each GCAT Show.

MEDICATION CONTROL:

The medication testing of all championship medal winners is compulsory. Any horse may be tested at the discretion of the DC and the show organizer. All medication testing will be conducted according to ECAHO Rules for Medication Control.

INDIVIDUAL RANKING:

HORSES

GCAT assigns GCAT points to the **top 10 horses in each of its six championship categories** at every GCAT Show. These categories include Yearling Males, Yearling Females, Junior Males, Junior Females, Senior Males, and Senior Females, totalling 60 horses. Points are primarily distributed based on the championship ranking each horse has earned. When championship points are not applicable, rankings are determined by the highest total score in each horse's qualifying classes. The points are distributed as follows:

1st place	20 points
2nd place	17 points
3rd place	15 points
4th place	13 points
5th place	12 points
6th place	11 points

HANDLERS

GCAT assigns GCAT points to the top 10 handlers in each of its six championship categories at every GCAT Show, based on the achievements of their horses. Only the **top 3 results** of a handler are taken into consideration in a GCAT Show. The points are distributed as follows:

1st place	20 points
2nd place	17 points
3rd place	15 points

PRIZE MONEY DISTRIBUTION FOR INDIVIDUAL RANKING – GCAT FINAL – ALL NATIONS CUP AACHEN:

Prize money is designated for the **top 10 horses in each championship category** during every GCAT Show. The categories include yearling females, yearling males, junior females, junior males, senior females, and senior males. In the **GCAT Final** individual ranking, the total prize money for the top 10 horses in each championship category across all championship classes amounts to **\$ 996,000** and is distributed as follows:

PRIZE MONEY FOR 42. All Nations Cup - The Lady Harmsworth Blunt Memorial Trophy:

The nation achieving first place in the All Nations Cup - The Lady Harmsworth Blunt Memorial Trophy shall be awarded total prize money of **\$ 50,000**. The prize money shall be distributed in equal shares among all owners/farms represented by horses participating for the winning nation in the All Nations Cup. For the purpose of this distribution, each owner/farm shall constitute one prize-money recipient, irrespective of the number of horses owned by that owner/farm and participating for the winning nation. In the case of joint ownership, the joint ownership shall collectively constitute one prize-money recipient and shall be entitled to one equal share only. Eligibility for distribution shall be determined on the basis of the ownership and nation information officially submitted, accepted and verified for the All Nations Cup by the applicable closing date of entry.

OVERALL RANKING:

The GCAT overall ranking is determined by the total points earned by each horse and handler across all GCAT championships during the season. **To qualify for the overall ranking, a horse or a handler must have received points in the championship at the minimum of 80% of the season's events within the same calendar year. For the 2026 season, this corresponds to earning championship points in at least five (5) GCAT shows.**

In the event of a tie in points at the end of the season, the horse or handler with more event participations will be ranked higher. If the tie persists, the horse or handler with the highest total number of championship points will be ranked higher. Should the tie remain unresolved, the highest average score in the qualifying classes will serve as the final tiebreaker.

PRIZE MONEY DISTRIBUTION FOR THE OVERALL RANKING:

Prize money is allocated to the **top 20 female horses**, the **top 20 male horses**, and the **top 20 handlers** in the GCAT overall ranking (tour series).

Horse of the Tour: The horse that accumulates the highest total points will receive an **additional \$500,000 prize**.

Legend Horse: The horse that achieves first place in the overall ranking three times in its lifetime will, upon its third victory, be awarded an **additional \$2,000,000 prize**. After reaching this milestone, the horse may continue participating in GCAT shows but will be excluded from the GCAT overall ranking. It will remain eligible for prize money only in individual seasonal GCAT shows.

The total prize money allocated for the GCAT overall ranking amounts to **\$4,065,000** distributed as follows:

WITHHOLDING TAX:

Any prize money awarded to participants who are non- German tax residents shall be subject to withholding tax to be deducted at source, in accordance with applicable German tax laws and regulations. All participants are strongly encouraged to obtain independent tax, legal, and financial advice prior to registering for and participating in the event. The Show Organizer shall bear no responsibility for any tax liabilities, withholding obligations, deductions, or related consequences arising in connection with such prize money.

All winners shall be required to submit their certificate of tax residency and other supporting documentation as required by the German Tax Authority.

CANCELLATION AND REFUND:

In the event that a registrant unilaterally withdraws from the event, any applicable refund transaction fees shall be deducted from the refundable amount. This deduction shall not apply in cases of force majeure events beyond the registrant's reasonable control. Refunds shall be subject to process requirement of:

- Ninety (90) days for debit card transactions and transaction fees up to QAR 40 per transaction
- One hundred eighty (180) days for credit card transactions, and transaction fees up to QAR 116.00 per transaction.

MISCELLANEOUS:

It is not possible to cover every situation in these GCAT rules. Therefore, in the event of any unforeseen or exceptional circumstances, it is the responsibility of the Show Officials in accordance with the Show Organizers to make a decision that is fair and in keeping with the spirit of the rules. They should use their sound judgment and strive to achieve the intention of these rules as closely as possible.

Participation in GCAT events is at the sole risk of the owner. GCAT shall not be liable for any loss, injury, illness, or death of horses, handlers, or other persons, except in cases of proven gross negligence.

GCAT reserves the right to propose modifications to these rules, subject to ECAHO review and approval. Any approved changes shall take effect upon publication on the official GCAT website.

INTELLECTUAL PROPERTY AND MEDIA RIGHTS:

The Participant hereby acknowledges and agrees that GCAT shall have the right to capture, record, reproduce, and use photographs, video recordings, and any other form of media during the event, and shall be governed by the applicable GCAT Privacy Notice. This includes, without limitation, images or recordings depicting horses, handlers, participants, guests, staff, and any other individuals present at the event premises. Participants acknowledge that they have been provided with, or have had the opportunity to review, the GCAT Privacy Notice.

The individual or entity registering the horse(s) represents and warrants that they have informed, and shall ensure the awareness and acceptance of, all associated persons, including but not limited to guests, handlers, and staff, of the provisions set forth herein.

The Participant acknowledges that GCAT may display notices and signage at event entrances and throughout the venue advising attendees that photography, filming, and other media recording activities are taking place and that entry to the event premises constitutes acknowledgment of and consent to such activities to the extent permitted by applicable law.

Where any minor attends the event under the Participant's supervision, custody, or responsibility, the Participant represents and warrants that the minor's parent or legal guardian has been informed of and consents to the capture, recording, use, publication, and distribution of the minor's image, likeness, voice, and other identifying characteristics as contemplated by this clause, to the extent required by applicable law.

The Participant further agrees that GCAT shall bear no liability whatsoever for the capture, use, publication, or distribution of such media, to the fullest extent permitted by applicable law.

PUBLIC COMMUNICATIONS AND REPUTATION PROTECTION:

All registrants must ensure that any photographs, videos, statements, social media posts, or other content relating to the event that are shared publicly do not include:

- a) false or misleading statements of fact concerning GCAT, the event, its organisers, officials, participants, sponsors, or partners;
- b) unauthorised use, alteration, or misuse of GCAT's name, logo, trademarks, branding, or other intellectual property;
- c) harassment, abuse, threats, discriminatory remarks, or targeted personal attacks against GCAT, its representatives, officials, participants, sponsors, partners, or any other person connected with the event;
- d) disclosure of confidential, private, or non-public information obtained through participation in or association with the event; or
- e) content that unlawfully defames GCAT or any person connected with the event.

Nothing in this provision shall prevent registrants from expressing honest opinions, providing fair comment, raising good-faith concerns regarding welfare, safety, integrity, or regulatory matters, or making protected disclosures in accordance with applicable law.

Where GCAT reasonably determines that a registrant has breached this provision, GCAT may take appropriate action, including issuing a written warning, requiring the removal or correction of the relevant content, suspending the registrant's participation, or disqualifying the registrant from the event. Any action taken shall depend on the nature and seriousness of the breach.

REGISTRANT'S UNDERTAKING AND GOVERNING LAW

By registering a horse for participation in the event, the registrant irrevocably confirms, represents, and warrants that it has obtained, or shall obtain, the consent and acceptance of all persons associated with the registered horse(s), including without limitation owners, riders, handlers, trainers, grooms, employees, agents, contractors, and guests, to comply with and be bound by these Rules and Regulations. The registrant shall remain fully responsible for ensuring such compliance.

Any dispute arising out of or in connection with the event, participation therein, or these Rules and Regulations shall be exclusively governed by the laws of the Netherlands, and the courts of the Netherlands shall have exclusive jurisdiction over any such dispute.
